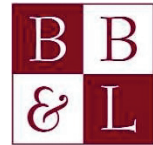

- *United States ex rel. Law Project for Psychiatric Rights v. Matsutani*, No. 3:09-cv-0080-TMB (D. Ak. Sept. 23, 2010) Represented health system and pediatric psychiatrist in False Claims Act litigation related to Medicaid payment for psychiatric medications prescribed off-label to minors. Obtained early dismissal of case with prejudice.
- *United States ex rel. Zemplyni v. Group Health Cooperative*, 2010 WL 3584444 (W.D. Wash Sept. 10, 2010) Represented health care provider in False Claims Act litigation and obtained government declination of intervention and early dismissal of False Claims Act and other allegations.
- *Perry v. Rado, et al.*, 504 F. Supp. 2d 1043 (E.D. Wash. 2007), *aff'd*, 343 Fed. Appx. 240 (9th Cir. 2009). Represented hospital and physician defendants in hospital peer review antitrust action by obstetrician. Obtained dismissal of the Complaint.

Represented four hospital defendants in False Claims Act litigation related to investigational cardiac procedures billed to Medicare. related to teaching physician billing to Medicare and Medicaid. Matter settled before trial.

- *Yarger v. Yakima Surgical Associates, et al.* CY-03-3018-WFN (E.D. Wash. 2004) Represented a defendant hospital in antitrust litigation relating to alleged conspiracy to monopolize general surgery market. Matter settled with nominal contribution by hospital.
- *U.S. ex rel. Harrington v. Sisters of Providence Health System*, 209 F. Supp. 2d 1085 (D. Or. 2002). Represented the Defendants in False Claims Act lawsuit alleging fraud in partial hospitalization psychiatric service. Initial complaint dismissed by District Court, and case subsequently dismissed on jurisdictional grounds.
- *U.S. ex rel. Aflatooni v. Kitsap Physicians Services, et al.*, 163 F.3d 516 (9th Cir. 1999); *dismissed* 314 F.3d 995 (9th Cir. 2002). Represented Defendant physician group in False Claims Act litigation alleging pathology service fraud. District Court dismissal of Complaint on jurisdictional ground initially reversed by appellate court. Defendants later won summary judgment dismissal of the case, which was affirmed by Ninth Circuit.
- *U.S. ex rel. Palchikovskiy v. Oregon Health Sciences University, et al.* 2001 U.S. App. Lexis 16545 (9th Cir. 2001) Represented the Defendants in a False Claims Act lawsuit alleging fraud in University foreign translation services. Summary judgment dismissal of case affirmed.
- *U.S. ex rel. Schreiner v. Harborview Medical Center, University of Washington, Providence Medical Center, Children's Hospital and Airlift Northwest.* (W.D. Wash. No. C96-519R, July 27, 1998) Represented the Defendants in False Claims Act litigation alleging Medicare hospital cost report fraud related to air ambulance service. Court dismissed Complaint under public disclosure bar.
- *U. S. ex rel. Latham v. Brim Healthcare, et al.* (D. Montana CV 96-008 BLG JDS, April 1997) Represented Defendant health care system and hospital in False Claims Act litigation alleging medically unnecessary services and falsification of documentation. Complaint against Defendants dismissed by Court.

- *Perry v. Rado, et al.* 230 P.3d 203, 2010 WL 1610746 (Washington Ct. of App. Div III 2010) Represented hospital and physicians in defending peer review termination of obstetrician. Defense summary judgment and award to defendants of substantial attorney fees in defense of action.
- *Oda v. University of Washington*, 111 Wn. App. 79, 44 P.3d 8 (Wash. Ct. App. 2002) Represented Defendant University in defeating class certification in faculty discrimination case related to compensation and promotion.

- *Caritas Services v. Washington Department of Social and Health Services* 123 Wash. 2d 391; 869 P.2d 28 (1994) Represented Plaintiff skilled nursing facility in judicial review of Medicaid cost report appeal. Washington Supreme Court upheld award to skilled nursing facility and invalidated as unconstitutional statutes and regulations that purported to retroactively clarify payment scheme.
